Legal Basis of Appointment Dasar Hukum Pengangkatan	He was appointed as the Company's Commissioner at 2019 Annual GMS and reappointed according to the 2023 Annual GMS resolution, effectively serving as per 15 June 2023. Career Karir	He started his career at PT National Semi Conductor Indonesia, Bandung in 1978, where he held several positions before being promoted to Process Engineering Manager in 1985. After that, he continued his career by joining the Company as a graduate trainee in 1986. He held a number of positions with the Company before being promoted to General Manager Customer Service in 2003, General Manager of Supply Chain in 2006, and Government & Public Affairs Head in 2008. After his official retirement in 2009, he was appointed to the Audit Committee and named an Independent Director of the Company, before being appointed to the Board of Commissioners in 2019. Beliau memulai kariernya di PT National Semi Conductor Indonesia, Bandung pada tahun 1978, dan menjabat di beberapa posisi sebelum dipromosikan sebagai Process Engineering Manager pada tahun 1985.
