## Code of Conduct

### Kode Etik Perusahaan

The Company adheres to a code of business and work ethics through Goodyear's Group Business Conduct Manual (BCM), which is applied on a global scale.

Perseroan menerapkan kode etik bisnis dan kerja melalui Buku Pedoman Perilaku Bisnis Grup Goodyear atau *Business Conduct Manual (BCM)* yang diterapkan dalam skala global.

BCM contains guidelines that must be followed by every associates of Goodyear's Group in carrying out their duties according to the Goodyear's Group embedded culture. BCM sets out and summarizes business ethics and ethical behaviour for all associates of Goodyear's Group to achieve the vision, mission, goals, and strategies of Goodyear's Group.

BCM adalah pedoman yang harus diikuti oleh setiap karyawan Grup Goodyear dalam menjalankan aktivitasnya sesuai dengan budaya yang ditanamkan. BCM memuat dan merangkum nilai-nilai etika bisnis dan etika perilaku bagi seluruh karyawan Grup Goodyear untuk mendukung pencapaian visi, misi, tujuan, dan strategi Grup Goodyear.

BCM is fairly and equally applicable to all associates in all organization levels without differentiating races, religion, and social class.

BCM berlaku secara adil dan setara kepada seluruh karyawan di semua jenjang jabatan tanpa membedakan latar belakang suku, ras, agama, dan kelas sosial.

The Company regularly socializes BCM through meetings, face-to-face meetings, e-mail, seminar, trainings, and associates' activities. The violations of BCM will be given sanctions set in the Company's Regulations, aligned with the compliance to the prevailing laws and regulations.

Perseroan melakukan sosialisasi BCM secara rutin melalui rapat-rapat, pertemuan tatap muka, e-mail, seminar, pelatihan, serta kegiatan-kegiatan karyawan. Pelanggaran terhadap BCM akan dikenakan sanksi yang telah diatur dalam Peraturan Perseroan, selaras dengan pemenuhan terhadap peraturan perundang-undangan yang berlaku.



In 2023, the Company provided training for all associates with one of the materials was refreshment of Code of Conducts understanding. The training aims to ensure associates always obey and act based on the Company's code of ethics.
